**SACRAMENTO** – The Commission will hold the 2006 Inspector Training Course on Monday June 5, 2006 at the Junipera Serra State Office Building located at 320 West Fourth Street, Conference Room, 1st Floor in downtown Los Angeles. An agenda and training packet will be sent out to all attendees before the training.

This training is mandatory for all present Inspectors and is open to a limited number of business professionals who meet the Inspector qualifications set by the Commission.

Inspectors are the core of enforcement for the Commission. Developing a top notch professional Inspector team is a priority for the Commission.

Inspectors work at the pleasure of the Executive Officer. They will perform their duties under his direction and or that of the Chief Athletic Inspector and or the Assistant Chief Athletic Inspector. They perform work involved in enforcing State law and rules of the Commission regulating boxing, kickboxing, and martial arts.

Typical tasks for the Inspector are:

- Attend and perform various functions at boxing, kickboxing, and full-contact martial arts events
- Enforce State law and rules of the Commission
- Make recommendations regarding the issuance of licenses
- Investigate applications for licenses and write reports on the findings
- Evaluate officials' and other licensees' performance
- Collect fines and purses withheld from contestants as penalties or forfeitures
- Instruct individuals regarding the requirements of the law and the rules of the Commission
- Calculate attendance, and submit reports of gross receipts and State taxes at events
- Submit Incident Reports that result from investigations
- Appear and testify at Commission and judicial hearings

Current or former law enforcement personnel who are or were in good standing with their agencies are strongly encouraged to apply. Outside interested parties are to submit their professional resume and three (3) verifiable professional references via e-mail or fax to:
