Since this is the weekend that the UFC 63 event takes place at the Anaheim Pond on Saturday September 23, 2006, an effort will be made to have licensed officials who attend the training go to the UFC 63 event if they would like to.

The training will provide the aspiring Referee and or Judge an introduction to our Athletic Commission Program (ACP) and an opportunity to become part of our apprentice program through commitment and dedication.

For the established official the training will provide Association of Boxing Commissions (ABC) Certification (only to individuals licensed by an ABC member) and a thorough review of our existing rules, as well as meeting the requirement of Business and Professions Code Section 18731 that mandates participation in a sponsored clinic.

The ABC certification examination can be taken voluntary. Although it is not an ACP requirement to become ABC certified, I strongly recommend that all officials become certified.

Through existing regulation and for the benefit of the athletes and the sport, the ACP has determined that notwithstanding any boxing rule, in its discretion, alternate provisions (ABC Uniform Championship Rules and Referee Guidelines) will govern championship bouts that are held in the State of California.

Ideally, all officials will attend the Ringside Physician training.

Although the ACP is authorized to pay any necessary and authorized travel expenses to those who attend clinics, funds are not available to do so at this time.

I would be greatly appreciative if you attend this training.
