Agenda Item 1 - Call the meeting to Order/Roll Call/Pledge of Allegiance/Establishment of

The meeting was called to order at 10:00 a.m. and a quorum was present.

Agenda Item 2 - Welcome - Chairman's Opening Remarks

Chairman Carvelli welcomed everyone to the Orange County Fairgrounds for the meeting. He mentioned that Commissioner John Frierson is getting better and should be at the next scheduled Commission Meeting.

Agenda Item 3 - Approval of the February 2, 2016, Commission Meeting Minutes

Commissioner Shen-Urquidez motioned to approve the February 2, 2016, Commission Meeting minutes as presented.

Commissioner Van Gordon Sauter seconded the motion.

The motion passed 6-0 by roll call vote.

<u>Agenda Item 5 – Discussion and possible action regarding delegation of amateur boxing</u> to USA Boxing

CONFIRMATION OF NOT-FOR-PROFIT ORGANIZATION

Commissioner Martha Shen-Urquidez motioned to confirm that based on information attained from the Secretary of State Office, USA Boxing is in fact a domestic not-for-profit organization. Vice-Chair Mary Lehman seconded the motion.

The motion passed 6-0 by roll call vote.

APPROVAL OF REVISIONS TO BY-LAWS

Commissioner Martha Shen-Urquidez motioned to approve revisions to USA Boxing's by-laws. Vice-Chair Mary Lehman seconded the motion.

The motion passed 6-0 by roll call vote.

SAFETY STANDARDS MEET OR EXCEED CSAC

Commissioner Martha Shen-Urquidez motioned to confirm that the safety and fairness standards in the USA Boxing by-laws that were submitted do in fact meet or exceeds those of the Commission's rulebook. Vice-Chair Mary Lehman seconded the motion.

The motion passed 6-0 by roll call vote.

OFFICIAL DELEGATION

Commissioner Martha Shen-Urquidez motioned to adopt the delegated agreement to USA Boxing. Commissioner Luis Ayala seconded the motion.

Commissioner Martha Shen-Urquidez revised her motion to include revisions as discussed. Vice-Chair Mary Lehman seconded the motion.

The motion passed 6-0 by roll call vote.

Agenda Item 5 - Executive Officers Report

Budget Update

Executive Officer (EO) Andy Foster reported that the Commission's revenue continues to be strong and should only increase as more events are requested in summer months.

He further reported that as of March 31, 2016, the Commission has deposited \$1,279,211 and spent \$1,085,118. The fund balance has increased to \$957,346. The Commission has \$385,885 dollars left in appropriation for the three remaining months of fiscal year 15/16.

Report on Pending and Proposed Regulations and Legislation

"Definitions, Prohibited Substances and Methods, Therapeutic Use Exemptions, Transgender Athletes" regulation is pending final review and approval at Business, Consumer Services and Housing Agency.

"Examination of Boxer Applicants and Neurological Assessment" regulatory proposal is pending Legal Counsel's review and approval.

"Payment to Contestants" regulatory proposal is pending Legal Counsel's review and approval.

"Headgear" emergency regulation package was submitted to OAL on April 11, 2016, and is currently being reviewed by their attorneys.

"Weighing Time, Time for Physical Examinations, and Dehydration and Rehydration" emergency regulation package is on today's agenda for action.

Status Update of Delegated Entities

CAMO - Amateur Mixed Martial Arts

EO Foster explained that CAMO was having difficulty implementing the body caliper testing and is requesting that the program be discontinued. Instead, Mr. Steele suggests the need to purchase bioelectric impedance scales.

Commissioner Van Gordon Sauter suggested that CAMO reach out to NCAA, local high schools and colleges to borrow/share the cost of scales.

Mr. JT Steele presented the Commission with a slight fee change in the official's licensing fee to allow reimbursement of air horns for Timekeepers.

USA Boxing- Amateur Boxing

EO Foster reported that USA Boxing has regulated 27 sanctioned events in the first quarter of 2016.

USFL- Youth Pankration

EO Foster reported that USFL has had one event in February and had two minor injuries.

IKF - Amateur Kickboxing

EO Foster reported that IKF has regulated 14 events since the last report on January 25, 2016.

d. Neurological Fund Update

EO Foster reported that the fund balance of the Neurological Fund as of FM 09 is \$621,000.

e. Pension Fund Update

EO Foster reported that the Pension investment account balance is \$5,151,186.82 as of March 31, 2016.

Chairman Carvelli created a Pension Fund Outreach Subcommittee by appointing Commissioner Luis Ayala and Vice Chair Mary Lehman, as well as members four volunteers; Dr. Lou Moret, Roy Englebrecht, Ray Corona, and Tony Crebs.

Agenda Item 6 - Subcommittee Updates

- a. Large Event Promotion Commissioner Shen-Urquidez gave an update; she stated that promoting large events entails branding the Commission, developing a great product, health and safety, and improving the Commission's profile.
- **b.** Officials Training Commissioner Shen-Urquidez gave an update on the status of officials training. She reported that there has been a significant increase in participation with the POD Index training component, and that most officials are compliant.
- c. Instant Replay Commissioner Shen-Urquidez provided the Commission with an overview of the option to use instant replay and her results from interviews with key industry stakeholders. Her survey concluded that, in general, most of the industry would like the option to utilize instant replay. The Commission further discussed the various obstacles for implementation.

Agenda Item 7 - Discussion and possible action regarding the Advisory Committee on Medical and Safety Standard's suggestion of free pregnancy testing kits that preserve fighter's privacy rights

The EO presented the Commission with a policy recommendation to consider providing, at no cost to the athletes, pregnancy testing kits in the restrooms at all weigh-ins. These tests would be totally voluntary and no request to take the test would be required or asked for by the Commission.

Vice Chair Lehman motioned to approve Commission staff to place pregnancy testing kits in the bathrooms at weigh-ins and to add the advisory statement of the dangers while fighting pregnant to the pre-bout medical questionnaire. Commission Shen-Urguidez seconded the motion.

The motion passed 6-0 by roll call vote.

Agenda Item 8 - Discussion and possible adoption of amendments to proposed emergency regulations sections 297 "Weighing Time" and 300 "Time for Physical Examinations" and section 299 "Dehydration and Rehydration", of Article 6 of Division 2, of Title 4 of the California Code of Regulations

The EO presented the Commission with a summary of this agenda. He provided an explanation that the emergency regulation language was coming back to the Commission for vote because during the review process of the initial language, the DCA Director and Executive Staff had concerns with section 297(a), further stating that it was unnecessary, considering that Ringside Physicians already have the authority in the law. Additionally, it was agreed to totally ban intravenous (IV) therapies with no exception. If an athlete requires IV therapy 24 hours before competing in a combat sporting event, the Ringside Physicians do not believe fighting is prudent.

The EO recommended approving the new regulatory emergency language proposed at the meeting.

Commissioner Ayala motioned to approve the proposed emergency language and authorize Commission staff to proceed with the emergency rulemaking process; Vice Chair Lehman seconded the motion.

The motion passed 6-0 by roll call vote.

Agenda Item 9 - Discussion and possible action regarding the State Athletic Commission Neurological Examination Account and C3 Logix testing.

The EO withdrew the memorandum that was provided in the Commission meeting materials and presented the Commissioners a memorandum from Melinda McClain, DCA Deputy Director of Legislative & Regulatory Review. The memorandum served to memorialize the DCA's correction regarding the Commission's interpretation, as presented in the meeting materials for this meeting, of Business & Professions Code 18711(d) which specifies what the Commissions spending authority shall be from the Neurological Examination Account. Historically, the Commission's spending authority was 30 percent of it's appropriation. However, the interpretation of this statute by DCA's Budget Officer, Taylor Schick, is the Commission is able to spend up to the full 30% of the entire fund balance. A Budget Change Proposal would be the correct course of action to increase the current appropriation amount, should the Commission so choose.

The EO recommend the Commission vote to direct the EO to purchase C3 Logix testing program that will provide a neurological baseline on all athletes, thereby establishing a record that can be measured after future injuries.

Commission Shen-Urquidez motioned to direct staff to purchase C3 Logix testing program for Neurological testing of athletes.

Public Comment: Roy Englebrecht asked if this test would be a requirement of licensure to replace the existing Neurological test that is already required.

Commissioner Ayala seconded the motion.

The motion passed 6-0 by roll call vote.

Agenda Item 10 – Consideration of proposed policy and procedure delineating Chair and Commissions' authority to speak on behalf of the Commission.

The EO and Legal Counsel presented to the Commissioners a policy to establish a foundation for accurate communications regarding the Commission's activities, including statements to the news media.

The EO speaks to the media about day to day issues of already established policy. This policy is for speaking for the Commission regarding something the Commission has not taken a formal position on that is not ministerial or administrative in nature.

Commissioner Ayala motioned to approve the policy presented to delineate the Chairman's and Commissioners' authority to speak on behalf of the Commission. Vice Chair Lehman seconded the motion.

The motion passed 6-0 by roll call vote.

A. Budget Update

The Commission's revenue for FY 15-16 was very good. Through 11 months of FY 15-16, the Commission deposited \$1,665,107 in revenue to the support fund while spending \$1,340,261. The Commission fund balance has increased to \$1,088,099, and should increase to over 1.2 million when the FM12 numbers are reported and finalized.

The Commission has deposited more revenue than in any year in at least the last 12 years.

B. Neurological Fund Update

The Commission's Neurological fund was appropriated \$64,000 for FY 15-16 and is projected to spend \$9,419. The fund will have an appropriation reversion of \$54,581 in FY 15-16. I anticipate spending the entire appropriation of \$61,000 in FY 16-17 on the C3 Logix neurological testing tools. I also have requested a positive budget change proposal for additional purchases of C3 Logix testing equipment, inspector salary costs, and other testing costs for FY 17-18 and ongoing.

C. Pension Fund Update

Enclosed is a graph that shows the Pension Plan payouts for the past 10 years. The payouts for 2016 are only through the first six months of the year, or June 2016.

D. Report on Pending and Proposed Regulations and Legislation

LEGISLATION: AB 2007 - This bill requires youth sport organizations to report suspected concussions to the parents of the youth participant. This bill includes youth full contact sports. It also requires organizations to offer education regarding head injury and concussions.

REGULATIONS:

• "Definitions, Prohibited Substances and Methods, Therapeutic Use Exemptions, Transgender Athletes" regulation was approved by Business, Consumer Services and Housing Agency and is pending approval at the Department of Finance.

- "Examination of Boxer Applicants and Neurological Assessment" regulatory proposal is pending Legal Counsel's review and approval.
- "Payment to Contestants" regulatory proposal is pending Legal Counsel's review and approval.
- "Headgear" emergency regulation package was approved and is now effective. We will begin the regular rulemaking process and the language is on the agenda today for approval.
- "Weighing Time, Time for Physical Examinations, and Dehydration and Rehydration" emergency regulation package was approved and is now effective.

G. Upcoming Event Schedule



I would recommend these two shows to the Commissioners.

Also, the Association of Ringside Physicians and the Association of Boxing Commissions will be holding their annual meetings at the Monte Carlo in Las Vegas from July 29th-August 4th. I am scheduled to speak at both meetings and am giving reports as the Chair of the Boxing Registry Committee. As you know, California has more boxing events than any other Commission, and the use of the registry is critical to the Commission's overall success. The contract for the current record keeper is up for renewal and the Committee is vetting the other interested contractors for possible selection as the National Official Record Keeper.



BOXER'S POSION FUND DISTRIBUTIONS BY YEAR - 2006-CURRENT










Value Over Time

Re: CAMO UPDATE / DOCUMENT REQUEST

Below and attached please find a CAMO update and report in anticipation of the CSAC meeting scheduled for July 12, 2016 in Los Angeles, CA:

1. CAMO MINIMUM WEIGHT STANDARDS: UPDATE

Starting in 2016, CAMO implemented the new Minimum Weight standard in California that involves testing the body fat of each contestant in order to determine the minimum weight at which the fighter may compete. The process, as previously presented to the Commission, involves performing a body fat test at the event, which is the key variable in the equation to determine the Minimum Weight. The current method involves an inspector using a digital skin caliper to measure the body fat of the contestant.

CAMO has now abandoned the use of the skin caliper as it proved to be too time consuming and involved too much user error. Therefore, CAMO has researched digital scales that are able to report body fat percentages in the price range of \$900. CAMO intends to purchase a sample scale to test reliability before purchasing a quantity

2. CAMO SAFETY AND SUSPENSION REPORT:

There have been no injuries of a heightened concern for the commission to review since the last CSAC meeting and report April 25, 2016.

3. FINANCIAL REPORT:



CAMO tax returns were extended due to the case load of our accounting firm and are filed. CSAC was provided with a copy, as usual.

4. WEIGH-IN TIMES:

There has been much discussion with weigh-in time in California and throughout industry. It appears that California and Nevada are both moving towards advanced weigh-ins allowing athletes more time to rehydrate. CAMO has always used same-day weigh-ins as a method to discourage weight cutting. Given the industry movement towards advanced weigh-ins CAMO would like to inquire about CSAC's position towards amateur weigh-ins. In general, CAMO has not experienced hydration-related problems but understands there is a need to develop athletes and prepare them for a professional career. We look forward to discussing this in the future.

5. FEMALE STATE CHAMPIONSHIP:

CAMO is pleased to announce that we have the first ever female state championship on July 2, 2016 in Santa Ana, CA. Historically, there have not been enough female athletes to coordinate a state championship. Although the number of female athletes is few, it is growing. We believe coordinating the state title for females will help foster more growth and add structure to the female program.

In closing, the summer season is off to a great start. We renew our resolve to continue working with CSAC and Executive Office Andy Foster to explore solutions to maximize fighter safety. Thank you for your continued support.

Thank you for granting USA Boxing the authority to conduct Olympic boxing programs throughout California. We are honored to serve 4,055 members within the four (4) California Local Boxing Committees. Of that total, 3,047 are participating athletes and 1,008 are the coaches and officials that train and mentor these young people on a daily basis. These boxing programs are carried out within 223 USA Boxing registered clubs and gyms in California.

During the second quarter (April 1, 2016 through June 29, 2016) USA Boxing sanctioned 52 boxing events with nearly 800 bouts boxing completed. There were no injuries reported during competition and ambulances were on site for all events. Athletes are required to have sports physicals prior to training in the gym with medical clearance noted in their passbooks.

On a very exciting note, the United States Olympic Committee has submittedLos Angeles as a Bid City to host the 2024 Summer Olympic Games. It remains one of three cities under consideration. We are very hopeful and encouraged that Los Angeles will be named the Host City in the Fall of 2017 and are ready to work with the State of California to ensure the L.A. Games are the most successful in Olympic history.

Sanctioned events within California are constantly updated and posted on the USA Boxing website (www.usaboxing.org) and the Matchtracker system which records athlete bout records is online and available to all Commission members. I am readily available to you and Commissioners and welcome contact regarding questions, comments and concerns most any time.

SUBJECT	Agenda Item #7 – Discussion regarding kickboxing regulations

It has been many years since the kickboxing regulations were reviewed and revised. I recommend beginning a discussion on revising the kickboxing regulations to better reflect contemporary kickboxing regulations.

Attached are first drafts of language that Commissioner Shen-Urquidez worked on for your review and discussion.

(PROPOSED) UNIFORM PROFESSIONAL KICKBOXING RULES

- 1. Bouts for male contests shall consist of a maximum of twelve (10) rounds of three (3) minutes each in duration with a minimum of one (1) minute rest period between each round.
- 2. The referee is the sole arbiter of the bout and is the only individual authorized to stop the contest. This rule shall not preclude a video or other review of a decision under the procedures of the applicable regulatory authority if a protest is filed claiming a clear rule violation.
- 3. All bouts are evaluated and scored by a maximum of three (3) judges.

5. Scoring:

- A. The 10 Point Must System will be the standard system of scoring a bout. Under the 10 Point Must Scoring System, 10 points must be awarded to the winner of the round.
- B. The fighter who has lost the round may be awarded 9, 8, or 7 points.
- C. If the round is determined to be an even round, a score of 10/10 may be awarded.
- D. Partial or incomplete rounds will be scored. If no action has occurred, the round shall be scored as an even round. This is at the discretion of the judges.
- 6. A mandatory Eight (8) Count after knock downs will be standard procedure in all bouts.
- 7: The Three (3) Knockdown Rule is in effect where a fighter has been knocked down 3 times in the same round by strikes/kicks to the head. In this event, this fighter shall be determined to have lost the bout by TECHNICAL KNOCKOUT. (??)
- 8. The is **NO** Standing Eight (8) Count.
- 9. A fighter who has been knocked down <u>CANNOT</u> be saved by the bell even in the last round.

- 10. All fighters are required to wear a mouthpiece during any contest. No round can begin without the mouthpieces in place. If any mouthpiece becomes dislodged during the contest, the referee shall call time and have the mouthpiece rinsed and put back in the fighter's mouth at the first opportune moment, without interfering with the action. The referee may deduct points if he/she feels the mouthpiece is being intentionally dislodged.
- 11. A fighter shall receive a 20 second count if the fighter is knocked out of the ring and onto the floor. The fighter shall **NOT** be assisted by anyone, including spectators or his seconds. If the fighter is assisted, he may be deducted points, or disqualified, at the sole discretion of the referee.

12. Fouls:

- A. Head butts.
- B. Groin strikes.
- C. Thrust kicks to the knee: Kicks to the front of a fighter's knee are illegal.
- D. Rabbit punches.
- E. Sweeps except with the instep portion of the foot. (???)
- F. Attacks to the throat.
- G. Striking a downed fighter.
- H. Failure to obey the referee's commands.
- I. Striking on a break.
- J. Striking after a bell.
- K. Holding or using the ropes while striking or clinching.
- L. Timidity: Intentionally avoiding a fights or contact with the opponent.
- M. Use of abusive language and/or gestures.
- N. Causing intentional delays in the action: For example, repeatedly spitting out the mouth piece, falling out of the ring to cause delay.
- O. Eye gouging.
- P. Holding the opponent's leg while executing more than one striking technique.
- Q. Judo techniques and wrestling submissions.
- R. Biting.

- S. Spiting at the opponent.
- T. Elbow strikes.
- U. Attacks to the foot other than sweeps.
- V. Clinching for more than 3 seconds. (??)

13. Permissible Strikes:

- A. Spinning backhands/fists to permissible target areas.
- B. Leg kicks with the top of the foot or shin only to permissible target areas.
- C. Sweeps with the instep portion of the foot. (??)
- E. All boxing strikes to permissible target areas.
- F. Spinning kicks to permissible target areas.
- G. Knee strikes to permissible target areas.

<u>Permissible target areas</u>: a) front and sides of the head; b) front and sides of the torso above the belt; c) inside and outside of the legs, except the knees.

- 14. A fighter who sustains an injury from a fair blow, which is severe enough to terminate the bout, shall lose by **TECHNICAL KNOCKOUT.**
- 15. A fighter who is hit with an unintentional low blow must continue the bout after a reasonable amount of time, but no more than five (5) minutes. If, after five minutes, the injured fighter cannot continue the bout, the outcome is determined by the scorecards.
- 16. Injuries Sustained by <u>Intentional</u> Fouls:
 - A. If an intentional foul causes an injury, which is severe enough to terminate the bout immediately, the fighter causing the foul **shall** lose by **DISQUALIFICATION**.
 - B. If the referee determines that a contest may continue despite an injury caused by an intentional foul, the referee shall immediately inform the Commission's representative and the judges and shall deduct TWO POINTS from the fighter who committed the foul.

- C. If an injury caused by an intentional foul results in the contest being stopped later in the bout, or in a later round:
 - (i) If the injured fighter is ahead on the scorecards, he shall be declared the winner by a **TECHNICAL DECISION**, or
 - (ii) If the injured fighter is behind or even on the scorecards, the contest shall be declared a **TECHNICAL DRAW**.
- D. If a fighter injures himself while attempting to foul his opponent, but is able to continue fighting, the referee shall take no action and treat the injury as if produced by a fair blow. If the referee determined fighter who injured him/herself is unable to continue, that fighter will lose by TECHNICAL KNOCKOUT/KNOCKOUT.

17. Injuries Sustained By <u>Unintentional</u> Fouls:

- A. If an unintentional foul causes an injury, which is severe enough to terminate the bout immediately, the contest shall result in a **NO DECISION**, if stopped before a bout has completed the rounds necessary to score a technical decision.
- B. If an unintentional foul causes an injury, which is severe enough to terminate the bout once the bout has been justified, the bout shall be awarded to the fighter ahead on the scorecards, including incomplete rounds, by way of a **TECHNICAL DECISION**.
- 18. Foot pads, shoes, or any type of foot gear are prohibited.
- 19. Male contestants must not wear clothing or other attire on their upper bodies.
- 20. No fighter may leave the ring before the end of the bout. Should the fighter fail to resume the bout following the end of the rest period, the referee shall begin counting as though there were a knock-down. At the conclusion of the count, the opponent shall be awarded the bout by way of **TECHNICAL KNOCKOUT.**

(PROPOSED) UNIFORM PROFESSIONAL MUAY THAI RULES

- 1. Before the beginning of every bout, fighters shall pay homage in accordance with the art and customs of Muay Thai. Once the ceremony is over, arm bands, head gear and other ceremonial attire shall be removed for the duration of the bout. Only attire approved by the local regulatory body shall be worn during the bout.
- 2. The limited application of petroleum jelly or lubricant as approved by the local regulatory body is permissible. However, oils and greases such as Tiger Balm are prohibited.
- 3. Bouts for male contests shall consist of up to five (5) rounds of three (3) minutes each in duration, with a maximum of two (2) minutes rest period between each round.
- 4. Bouts for female contests shall consist of up to five (5) rounds of two (2) minutes each in duration, with a maximum of two (2) minutes rest period between each round.
- 5. The referee is the sole arbiter of the bout and is the only individual authorized to stop the contest. This rule shall not preclude a video or other review of a decision under the procedures of the applicable regulatory authority if a protest is filed claiming a clear rule violation.
- 6. All bouts are evaluated and scored by a maximum of four (4) judges.

7. <u>Scoring</u>:

- A. The 10 Point Must System will be the standard system of scoring a bout. Under the 10 Point Must Scoring System, 10 points must be awarded to the winner of the round.
- B. The fighter who has lost the round may be awarded 9, 8, or 7 points.
- C. If the round is determined to be an even round, a score of 10/10 may be awarded.
- D. Incomplete rounds must be scored, with any point deductions for the partial round calculated in the final score.

- 8. A mandatory Eight (8) Count after knock downs will be standard procedure in all bouts.
- 9. There is **NO** Three (3) Knockdown Rule.
- 10. There is **NO** Standing Eight (8) Count.
- 11. A fighter who has been knocked down **CANNOT** be saved by the bell in any round.
- 12. All fighters are required to wear a mouthpiece during any contest. No round can begin without the mouthpieces in place. If any mouthpiece becomes dislodged during the contest, the referee shall call time and have the mouthpiece rinsed and put back in the fighter's mouth at the first opportune moment, without interfering with the action. The referee may deduct points if he/she feels the mouthpiece is being intentionally dislodged.
- 13. A fighter shall receive a 20 second count if the fighter is knocked out of the ring and onto the floor. The fighter is not to be assisted by spectators or his seconds. If the fighter is assisted, he may be deducted points, or disqualified, at the sole discretion of the referee.

14. <u>Fouls</u>:

They are at the sole discretion of the referee. The foul may result in a warning, a one or two-point deduction or disqualification. The decision is based upon the severity of the foul and the perceived intention of the fouling fighter.

- A. Head butts.
- B. Groin strikes.
- C. Thrust kicks to the knee: Kicks to the front of a fighter's knee are illegal.
- D. Rabbit punches.
- E. Strikes to the spine.
- F. Strikes to the throat.

- G. Striking a downed fighter: Stepping or hitting a fighter who has fallen is illegal.
- H. Failure to obey the referee's commands.
- I. Striking on a break.
- J. Striking after a bell.
- K. Holding or using the ropes as a weapon: For example, when a fighter pushes an opponent's face across the ropes in an effort to cut them.
- L. Timidity: Intentionally avoiding a fights or contact with the opponent.
- M. Use of abusive language and/or gestures.
- N. Causing intentional delays in the action: For example, repeatedly spitting out the mouth piece, falling out of the ring to cause delay.
- O. Eye gouging.
- P. Hair pulling.
- Q. Catching a kick and pushing for more than two (2) steps without attempting an attacking technique: It is permissible to catch a kick. and walk up to two (2) steps.
- R. Biting.
- S. Spiting at the opponent.
- T. Holding or grabbing the opponent's clothing: Fighters cannot pull or grab their opponents, twist them or attempt to land on top of them
- U. Interference from a fighter's corner.
- V. Tripping or sweeping the opponent: It is legal to use the top of the foot to kick the opponent off their feet. It is not legal to use the side of the foot to sweep the opponent off their feet. Fighters shall not step across the other to trip.
- W. Hip throws: Throws such as in Judo, Sambo, Jujitsu are illegal. Fighters shall not use their shoulder to throw their opponent such as in Judo or Reap.
- X. Wrestling submissions: Neck or shoulder manipulations, however, it is legal to throw an opponent to the canvas without using their body as a barrier.
- Y. Fake throwing oneself onto the canvas after being caught attempting a kick. It is considered taking advantage.
- Z. Lifting and throwing opponent to the canvas.

- 15. A fighter who sustains an injury from a fair blow, which is severe enough to terminate the bout, shall lose by **TECHNICAL KNOCKOUT.**
- 16. A fighter who is hit with an unintentional low blow must continue the bout after a reasonable amount of time, but no more than five (5) minutes. If, after five minutes, the injured fighter cannot continue the bout, the outcome is determined by the scorecards up to and including the round, even if partial, in which the low blow occurred.

17. Injuries Sustained By Intentional Fouls:

- A. If an intentional foul causes an injury, which is severe enough to terminate the bout immediately, the fighter causing the foul **shall** lose by **DISQUALIFICATION**.
- B. If the referee determines that a contest may continue despite an injury caused by an intentional foul, the referee shall immediately inform the Commission's representative **and** the judges and **shall** deduct **TWO POINTS** from the fighter who committed the foul.
- C. If an injury caused by an intentional foul results in the contest being stopped later in the bout, or in a later round:
 - (i) If the injured fighter is ahead on the scorecards, he shall be declared the winner by a **TECHNICAL DECISION**, or
 - (ii) If the injured fighter is behind on the scorecards, the contest shall be declared a **TECHNICAL DRAW**.
- D. If a fighter injures himself while attempting to foul his opponent, the referee shall treat the injury as if produced by a fair blow.

18. Injuries Sustained By <u>Unintentional</u> Fouls:

- A. If an unintentional foul causes an injury, which is severe enough to terminate the bout immediately, the contest shall result in a **NO DECISION**, if stopped before 2 rounds have been completed.
- B. If an unintentional foul causes an injury, which is severe enough to terminate the bout after 2 rounds have been completed, the bout shall be

awarded to the fighter ahead on the scorecards, including incomplete rounds, by way of a **TECHNICAL DECISION**.

SUBJECT	Agenda Item #8 – Review and approval of proposed regulations to adopt section 610, of Division 2, of Title of the California Code of Regulations

BACKGROUND

On February 2, 2016, the Commission approved emergency regulations to adopt section 610, of Division 2, of Title of the California Code of Regulations "Headgear."

This emergency regulation package was approved by the Office of Administrative Law on April 21, 2016. Per the Administrative Procedure Act, the Commission has 180 days to complete the regular rulemaking process on the emergency language. In addition, during OAL's review of the emergency language, it was brought up that the language could contain additional information on the criteria used to approve headgear. As a result, the Commission's legal counsel made changes to the language. These changes are attached for the Commission's review and approval.

RECOMMENDATION

It is recommended the Commission approve the amendments to proposed "Headgear" language and authorize Commission staff to proceed with the rulemaking process.

California State Athletic Commission Amendment to Emergency Regulation

Adopt Section 610 of Division 2, of Title 4 of the California Code of Regulations § 610. Headgear

- (a) In addition to that equipment in Sections 318, 322 and 323 of these regulations, amateur boxing competitors shall wear headgear that is approved by the commission. All approved headgear shall protect both the head and face of the competitor.
- (b) Notwithstanding subdivision (a), the Commission shall determine whether an exception shall be made to requirements set forth in subdivision (a) in an event where the competitor is seeking to qualify as a member of the USA Boxing National Team for the purpose of competing in the Olympic Games Competition. In making this determination, the Commission shall consider:
 - (1) Whether the event is an International Olympic Style boxing event.
- (2) Whether the competition involves USA Boxing National Team athletes competing against International Boxing Federation's National Team athletes.
- (3) Whether the amateur boxing competitors are over the age of 18 or will meet this age prior to the commencement of the Olympics.
- (4) Whether the event is an international bout that may include International Dual Matches and International Tournaments in which USA Boxing National Team competitors participate for the intended purpose of qualifying for Olympic Games Competitions.
- (c) All approved headgear shall meet the construction specifications approved by United States Amateur Boxing, Inc. (USA Boxing) or an equivalent organization.

BACKGROUND

Assembly Bill 2007 will establish requirements for sports organizations to report and remove athletes from competition who may be suspected of receiving a concussion during training or competition. It will require a medical examination before return to play/competition is authorized. This bill also requires annual education on concussions for participants and will require coaches and administrators to successfully complete a head injury education course.

RECOMMENDATION

I recommend the Commission discuss this bill and take a position of support if the Commission determines that this bill promotes health and safety of youth athletes.

SUBJECT: Youth athletics: youth sports organizations: concussions or other head injuries

SUMMARY: Establishes requirements for youth sports organizations to remove an athlete who is suspected of sustaining a concussion or other head injury until he or she is evaluated and cleared by a licensed health care provider.

Existing law:

- 1) Requires, a school district, charter school, or private school that elects to offer an athletic program, to comply with both of the following.
 - a) Require an athlete who is suspected of sustaining a concussion or head injury in an athletic activity to be immediately removed from the athletic activity for the remainder of the day, and not permitted to return to the athletic activity until he or she is evaluated by a licensed health care provider who is trained in the management of concussions and is acting within the scope of his or her practice. Prohibit the athlete from returning to the athletic activity until he or she receives written clearance to return to the athletic activity from that licensed health care provider.
 - b) Require, if the licensed health care provider determines that the athlete sustained a concussion or a head injury, the athlete to also complete a graduated return-toplay protocol of no less than seven days in duration under the supervision of a licensed health care provider.
 - c) Urges the California Interscholastic Federation is urged to work in consultation with the American Academy of Pediatrics and the American Medical Society for Sports Medicine to develop and adopt rules and protocols to implement b) above.
 - d) Require, on a yearly basis, a concussion and head injury information sheet to be signed and returned by the athlete and the athlete's parent or guardian before the athlete initiates practice or competition.
 - e) Exempts an athlete engaging in an athletic activity during the regular schoolday or as part of a physical education course, as specified.

This bill:

- 1) Requires a youth sports organization that elects to offer an athletic program to comply with all of the following:
 - a) Require an athlete who is suspected of sustaining a concussion or other head injury in an athletic activity to be immediately removed from the athletic activity for the remainder of the day, and not permitted to return to any athletic activity until he or she is evaluated by a licensed health care provider;

- b) Prohibit the athlete from returning to athletic activity until he or she receives written clearance to return to athletic activity from a licensed health care provider;
- c) Require, if the licensed health care provider determines that the athlete sustained a concussion or other head injury, the athlete to also complete a graduated return-to-play protocol of no less than seven days in duration under the supervision of a licensed health care provider;
- d) Require if an athlete who is 17 years of age or younger has been removed from athletic activity due to a suspected concussion, the youth sports organization to notify a parent or guardian of that athlete of the time and date of the injury, the symptoms observed, and any treatment provided to that athlete for the injury;
- e) Require on a yearly basis, the youth sports organization to give a concussion and head injury information sheet to each athlete;
- f) Require the information sheet to be signed and returned by the athlete and, if the athlete is 17 years of age or younger, to also be signed by the athlete's parent or guardian, before the athlete initiates practice or competition;
- g) Permit the information sheet to be sent and returned through an electronic medium including, but not necessarily limited to, fax or electronic mail;
- h) Require each coach and administrator to be required to successfully complete the concussion and head injury education offered pursuant to i) below at least once, either online or in person, before supervising an athlete in an activity of the youth sports organization;
- i) Require on a yearly basis, the youth sports organization to offer concussion and head injury education, or related educational materials, or both, to each coach and administrator of the youth sports organization; and,
- j) Require the youth sports organization to identify both of the following:
 - i. An individual within the organization who is responsible for ensuring compliance by the organization with the requirements for providing concussion and head injury education contained in paragraph h) above; and,
 - ii. Procedures to ensure compliance with the athlete removal provisions and the return-to-play protocol required pursuant to paragraph a-c) above.
- 2) Establishes definitions including that a "youth sports organization" means an organization, business, nonprofit entity, or a local governmental agency that sponsors or conducts amateur sports competitions, training, camps, or clubs in which persons 17 years of age or younger participate in any of the following sports:
 - a) Baseball;
 - b) Basketball;
 - c) Bicycle motocross;
 - d) Boxing;
 - e) Competitive cheerleading;
 - f) Full Contact Martial Arts:
 - g) Diving;
 - h) Equestrian activities;
 - i) Field hockey;
 - i) Football;
 - k) Gymnastics;
 -) Ice hockey;

- m) Lacrosse;
- n) Parkour;
- o) Rodeo;
- p) Roller derby;
- q) Rugby;
- r) Skateboarding;
- s) Skiing;
- t) Soccer:
- u) Softball;
- v) Surfing;
- w) Volleyball;
- x) Water polo; and,
- y) Wrestling.
- 3) Defines "licensed health care provider" as a licensed health care provider who is trained in the evaluation and management of concussions and is acting within the scope of his or her practice.
- 4) Requires this bill to apply to all persons participating in the activities of a youth sports organization, irrespective of their ages. Prohibits anything in this bill from being construed to prohibit a youth sports organization, or any other appropriate entity, from adopting and enforcing rules intended to provide a higher standard of safety for athletes than the standard established under this bill.

COMMENTS:

- 1) Author's statement. According to the author, sports related injuries have become a growing concern in today's society. Research shows that sports related injuries are not always immediately visible or evident, but may manifest in the future with extremely negative effects on the athlete's health. Studies in the cumulative effects of concussion in young athletes show that even a mild concussion can result in serious long-term problems, especially if an athlete was returned to play too early, or has a history of concussions or other head injuries. The Legislature has already addressed concussion protocol in school sports, but more kids play sports in a community based setting, and with this legislation I hope to establish a proper protocol for concussion detections, treatment, and post-concussion management for youth sports leagues.
- 2) CDC. The CDC has information including training videos and fact sheets that are designed specifically for coaches, which can be found at http://www.cdc.gov/headsup/youthsports/coach.html The following is from a CDC fact sheet.

Concussion, a type of traumatic brain injury, is caused by a bump, blow, or jolt to the head. Concussions can also occur from a blow to the body that causes the head and brain to move

rapidly back and forth-literally causing the brain to bounce around or twist within the skull. This sudden movement of the brain causes stretching and tearing of brain cells, damaging the cells and creating chemical changes in the brain.

Sometimes people wrongly believe that it shows strength and courage to play injured. Some athletes may also try to hide their symptoms. Do not let your athlete convince you that he or she is "just fine" or that he or she can "tough it out." Discourage others from pressuring injured athletes to play. Emphasize to athletes and parents that playing with a concussion is dangerous. Most athletes with a concussion will recover quickly and fully. But for some athletes, signs and symptoms of concussion can last for days, weeks, or longer. If an athlete has a concussion, his or her brain needs time to heal. A repeat concussion that occurs before the brain recovers from the first—usually within a short time period (hours, days, weeks)—can slow recovery or increase the chances for long-term problems. In rare cases, repeat concussions can result in brain swelling or permanent brain damage. It can even be fatal.

- 3) Concussions and brain injuries in youth sports. One study published in December 2015 in the Rhode Island Medical Journal provided by the author, indicates that about 1.6-3.8 million sports-related concussions occur every year. Symptoms may appear mild but the injury can lead to life-long problems with physical function, concentration, memory, behavior, and emotional issues. Most concussions resolve within 7-10 days but the recovery process can be longer and more complicated in children and adolescents. Athletes with concussions are vulnerable to the second-impact syndrome where ongoing symptoms lead to another injury. Young athletes experience a complex recovery process after concussions. Recurrent concussions are especially destructive to the brain and are more likely during the first ten days after a concussion. It is recommended waiting at least seven days until return to play. The article indicates that education does reduce injuries. Among three groupings of coaches with none to varying levels of education about concussions, concussions in youth football players were lower in the group with the highest level injury prevention education compared to the non-educated cohort.
- 4) Prior legislation. AB 2127 (Cooley, Chapter 165, Statutes of 2014) limits full-contact football practices and requires a student-athlete who has suffered a concussion or head injury to complete a graduated return-to-play protocol of at least seven days, as specified.

AB 1451 (Hayashi, Chapter 173, Statutes of 2012), includes a basic understanding of the signs and symptoms of concussions and the appropriate response to concussions within the High School Coaching Education and Training Program, administered by school districts.

AB 1449 (Hayashi of 2012), would have required the Superintendent of Public Instruction to develop and make available a sample concussion and head injury information sheet for use by school districts. AB 1449 was held in the Assembly Education Committee.

AB 25 (Hayashi, Chapter 465, Statutes of 2011), requires a school district that elects to offer athletic programs to immediately remove an athlete who is suspected of sustaining a concussion or head injury during that activity; prohibits the return of the athlete to that activity until he or she is evaluated by, and receives written clearance from, a licensed health care provider; requires, on a yearly basis, a concussion and head injury information sheet to be signed and returned by the athlete and the athlete's parent or guardian before the athlete's initiating practice or competition.

AB 1646 (Hayashi of 2010), would have required training for coaches to be able to identify symptoms of head and neck injury. AB 1646 was held in the Assembly Appropriations Committee suspense file.

AB 1893 (Hayashi of 2010), would have required all high school spirit activities coaches to have valid certification in CPR and first aid, including an understanding of signs, symptoms, and appropriate emergency action steps regarding potentially catastrophic injury, including but not limited to, head and neck injury and concussion. Pupils participating in this activity who experience or show signs of trauma or other injury must obtain a release from the treating provider before resuming these activities. AB 1893 was held in the Assembly Education Committee.

AB 533 (Hayashi of 2009), would have required training for coaches to be able to identify symptoms of head and neck injury. AB 533 was held in the Assembly Appropriations Committee suspense file.

- 5) Support. The Brain Injury Association of California writes that young athletes experiencing head injuries are at greater risk of long-term brain damage if injured during the critical stages of brain development. From 2002 to 2012 the number of reported sports-related concussions among student athletes doubled. The increase is attributed to many factors including greater awareness and recognition of traumatic brain injuries. However, research also shows that it is likely that self-reported concussion symptoms are under diagnosed, which may lead to premature return to play. The California PTA supports this bill because research shows even mild concussions can have long-term negative consequences if not treated properly. The California School Nurses Organization believes extending the protections in this bill are necessary for those engaged in not only K-12 sports activities but those engaged in other organized sports activities.
- 6) Concern. CSAC Excess Insurance Authority (CSAC EIA) expresses concern about this bill indicating that an onus will be placed on youth sports organizations for recordkeeping and removal of athletes from activities when suspected of having a concussion. Youth sport organizations do not have the resources to evaluate a youth athlete for concussion. Coaches are volunteer parents from the community. CSAC EIA is concerned people will not want to volunteer as coaches and the bill would potentially create a basis for liability if a youth sports organization does not distribute and/or obtain a parent's signature on the information sheet.
